SUBJECT: SWRCB Extension Request Letter

Background

At the Board's Special meeting on January 17, 2017 staff recorded the following motion regarding **Agenda Item No. 8A: Cross Connection Control Compliance for Temelec Area Homes.**

Motion was made by Director Foreman directing staff to draft and send a letter to the SWRCB seeking a two year extension to the current deadline, seconded by Director Heneveld and unanimously approved by roll call vote.

Subsequent to the meeting, disagreement as to the content of the letter has developed and an unofficial letter was sent to the SWRCB. Staff is requesting clarification so an official District correspondence can be sent.
